- Convert without cost to shares of common stock on a one-for-one basis.
- The reported transaction involved the certification of the Company's performance for the award of 7,817 performance stock units. The reporting person has previously reported awards of restricted stock units in Table II of Form 4. The total reported in Column 5 includes the 7,817 unvested performance stock units reported herein, 27,635 restricted stock units previously reported in Table II, and 11,879 shares of common stock.
